The following tank mixes have been tested for physical compatibility with SONIS at recommended rates of use and will mix in the sprayer tank. No tests have been undertaken on crop safety or product performance, therefore use is at the user's own risk. Syngenta IRL Ltd will support the physical compatibility of 2 or 3-way tank mixes of SONIS + chlormequat (classed as one product) with any of the fungicides, herbicides, insecticides or PGRs listed except in the case of spring oats (see notes). **TRACE ELEMENTS**

Syngenta IRL Ltd advise that the trace element part of the tank mix is added to the sprayer tank last with constant agitation and the mixture is sprayed without delay.

## NOTES

Always use constant agitation of the sprayer tank during mixing, transportation and application. Spray immediately.

Syngenta IRL Ltd will not support the mixing of SONIS with any product containing carfentrazone-ethyl.

SONIS + chlormequat + SU + fungicide supported in winter wheat **only**.

<sup>2</sup>Only apply with SONIS @ 0.2 l/ha if absolutely necessary as crop phyto can occur. Leave 5-7 days between applications of Pacifica + Biopower and SONIS.

<sup>3</sup>Caution when mixing with SONIS as can cause crop phytotoxicity in winter & spring barley and oats.

<sup>4</sup>Syngenta IRL Ltd will only support the use of SONIS not SONIS + chlormequat on **spring oats**.
